Memorandum of Understanding

#### **ARTICLE 1: OBJECT:-**

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.

The two institutions shall seek to promote:

- A. Student Exchange: -Department of Mathematics, K. J. Somaiya College of Arts, Commerce & Science and Department of Mathematics, Ahmednagar College, Ahmednagar agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate. A host institution refers to an institution that receives a student for a brief period of time to undertake a pre-determined programme of study orresearch.
- ❖ Exchange students will be selected by mutual agreement between the home in stitution and the host in situation.
- An exchange student will continue to be treated as full time student at his/ her home institution.
- An exchange student will be considered as full time "exchange" student at the host institution.
- ❖ His/her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim" academic advisor identified by the hostinstitution.
- The host institution will evaluate an exchange students' performance in each course or module, award a letter grade or marks, and issue a letter to that effect.
- The home in situation may a ward to the exchange student credit serene data host institution, but only after the home institution has established correspondence between courses taken at the host intuition vis-a-vis those offered at the home institution.
- ❖ If an exchange student has undertaken research, then the host institution will evaluate the exchange students' performance in the research and issue a letter to that effect, together with a "Report" of the research carriedout.
- ❖ If an exchange student has undertaken research, then the home institution will taken of the performance evaluation and the technical report, and take steps in accordance with its own procedures.

- ❖ In the Department of Mathematics, K. J. Somaiya College of Arts, Commerce & Science and Department of Mathematics, Ahmednagar College, Ahmednagar, agree provide suitable accommodation and living expenses for student and faculty exchange.
- ❖ To avail travel expenses, students can apply for existing funding programs at their respective home universities.
- ❖ The exchange students will pay tuition and other fees at their home institution.

#### Other Areas:-

- To exchange information on research and educational programs.
- To exchange information on teaching, learning material and other literature relevant to their educational and research programs.
- To propose and engage jointly in research or training programs sponsored by funding agencies, and to invite each other's students to participate therein.
- To exchange, on are caporal basis, students at Undergraduate, Post Graduate level for limited periods of time for purpose of education and /or research.
- The provision of cultural and intellectual enrichment opportunities for students of both institutes.
- To use computer laboratories facility in specific cases for limited period.
- To permit students, to use libraryfacility.

Department of Mathematics, K. J. Somaiya College of Arts, Commerce & Science and Department of Mathematics, Ahmednagar College, Ahmednagar, agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for it implementation.

#### **ARTICLE 2: COORDINATION:-**

Each in situation shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of Department of Mathematics, K. J. Somaiya College of Arts, Commerce & Science and a programme coordinator of Department of Mathematics, Ahmednagar College, Ahmednagar, will periodically review and identify ways to strength cooperation between the two institutions.

### ARTICLE 3: CONFIDENTIAL INFORMATION:-

Department of Mathematics, K. J. Somaiya College of Arts, Commerce and Science do not absolve any confidential information during the activity.

## ARTICLE4: INTELLECTUAL PROPERTY RIGHTS:-

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both institutes to this Memorandum.

Both in statutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both institutes shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation right sand revenue sharing. Any publication regarding such intellectual property shall only be possible with the prior written consent of both institutes, such on sent not to be unreasonably with held.

Department of Mathematics, K. J. Somaiya College of Arts, Commerce and Science shall be free to us perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and public on purposes with out the payment of royal ties or other fees to the other party.

#### **ARTICLE 5: VALIDITY:-**

The Memorandum shall remain in force for a period of FIVE years commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

#### **ARTICLE 6: TERMINATION:-**

Either in stitution may terminate the MoU by giving written not ice of six months in advance to the other institution. Once terminated, neither Department of Mathematics, K. J. Somaiya College of Arts, Commerce & Science and Department of Mathematics, Ahmednagar College, Ahmednagar will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, Department of Mathematics, K. J. Somaiya College of Arts, Commerce & Science and Department of Mathematics, Ahmednagar College, Ahmednagar will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

## ARTICLE 7: AMENDMENTS/MODIFICATIONS:-

This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.

## ARTICLE 8: ADHERENCE TO LAWS:-

Participating students involved in any activities under this Memorandum must adhere to the law and rules and regulations of the in stitutions.

#### ARTICLE 9: LEGAL EFFECT:-

Nothing in this Memorandum shall be construed as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

### ARTICLE 10: DISPUTE RESOLUTION

In case, there is a dispute relating to any aspect of academic cooperation, Principal, K. J. Somaiya College of Arts, Commerce & Science and Head, Department of Mathematics, Ahmednagar College, Ahmednagar will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility. Department of Mathematics, K. J. Somaiya College of Arts, Commerce & Science and Department of Mathematics, Ahmednagar College, Ahmednagar welcomes the establishment of this Memorandum for cooperation and jointly agrees to the provisions as set outabove.
