This Memorandum of Understanding is made & entered on this 1st July 2020 between,

K.J. Somaiya Arts, Commerce & Science College,

Mohanirajnagar, Nagar-Manmad highway, Kopargaon, Dist-A. Nagar represented by Dr. B.S Yadav. Age - 55 Occupation Service Here in after called "College".which expression shall unless repugnant to the context means and include its successors and assigns of the One Part.

AND

Sahyadri Rose Garden & Nursery having its registered office at Astagaon, Tal: Rahata, Dist- A.Nagar Nursery address Sahyadri Rose Garden & Nursery, Astagaon, Nagar-Manmad Road Astagaon, Tal: Rahata, Dist- A.Nagar represented by Mrs. Manda Sharad Nimse, Age – 61 Occupation- Business. Proprietor here in after called "Sahyadri Nursery" of the second part.

WHEREAS

II part i.e. "Nursery" has accepted the proposal of I part i.e. "College" on dated 01 July 2020 with reference to that now this first revision date of MoU has come in force on this day as follows.

Relationship of Parties:

"College" is an educational institute of Kopargaon Taluka Education Society, Kopargaon is not legal representative or agent of Nursery. For any purpose shall have no right or authority (except of expressly provided in the MoU) to incur assume or create in writing or otherwise in warranty over any College employees all of whom are entirely under the College, who shall be responsible for their acts and omission.

Nothing contained in this MoU shall be deemed to create any partnership or other than service between the parties.

This is first execution of MoU. It is valid up to two years from the date execution and will be renewed after two years.

This MoU included following understandings.

- 1 "Nursery" shall provide the knowledge of medicinal and aromatic plants to the College students time to time without any cost. But the "College" will inform the "Nursery" two days before the visit.
- Nursery shall guide the College time to time for plantation of medicinal and aromatic, ornamental, flowering and vegetable plants, on request.
- 3 Any research and development activity regarding the medicinal and aromatic, ornamental, flowering and vegetable plants, will be shared to each other during the tenure of the MoU
- 4 College would provide technical knowledge to the Nursery time to time without any cost; same will be applicable to the Nursery.
- 5 Any opportunity in relation to the medicinal and aromatic, ornamental, flowering and vegetable plants, will be shared and discussed during the tenure of MoU.

- 6 If College require any seeds or planting material for their campus Nursery will provide planting material after the written order of College .For seeds, order delivery time is 6 days, seedlings 1 to 2 month where as for suckers 10 days.
- 7 If Nursery requires any planting material source from College campus, staff of the Botany Dept. will supply it with market rate, also the garden produced material will be noticed first to the Nursery before sales .If Nursery not wish to take the material, College will sale it to the other party with the help of Nursery or directly to the agent.
- 8 Any harvest of medicinal plants will be discussed with Nursery, after its approval College will harvest.
- 9 Any social, legal matter regarding the planting of herbs or shrubs will be discussed mutually before plantation.
- 10 Plant authentication and identification of new herb collected by Nursery will be certify by College without any cost.
- 11 If Nursery wish to do the valuable and quarantine material plating and their conservation Dept. of Botany of the College will provide technical staff or students for the said work.
- 12 For demonstrations in District, state or interstate exhibitions of the medicinal and aromatic, ornamental, flowering and vegetable plants, College and Nursery will participate the same mutually. For the said work College will provide staff and students with Nursery staff.
